In consideration of my, _____ (Print Full Legal Name), being permitted, for my own educational purposes and interests, to enter upon the premises of the Port Authority of Allegheny County d/b/a Pittsburgh Regional Transit ("PRT") for the Event, I on my own behalf and on behalf of my heirs, survivors, and estate, hereby release, hold harmless, and indemnify PRT and its officers, directors, assigns, employees and agents (hereinafter "Released Parties"), from and against, and assume the risk for, all damages, losses, injuries, and any and all other claims of any types whatsoever of personal injury (including death) and other loss or damage of any nature whatsoever including damage to personal property, **even if sustained or caused solely or in part as a result of the intentional or negligent actions of the Released Parties.** I further understand and acknowledge that this duty to indemnify, defend and hold harmless the Released Parties includes for any claims arising out of PRT's use of photographs, video and/or audio recordings of me taken during the Event, as detailed more fully herein.

In the event that a claim is made against Released Parties by any person or entity to recover damages as a result of my participation in activities associated with the Event, I do hereby covenant to defend, indemnify and save harmless Released Parties from and against all claims and demands whatsoever on account of, or in any way arising out of, an occurrence or its results both to person or property, including but not limited to any liens, subrogation rights or claims for medical expenses, and including but not limited to any claims or demands made by me now or at any time in the future, claims or demands made by any other individual or individuals claiming a legal, custodial or financial interest in or on behalf of me and/or claims or demands made by any insurance carrier, government entity or private company or entity relating to me arising out of my participation in the Event.

I give permission for me to be given emergency medical treatment and/or transportation, if necessary, in the event of an accident, injury or sudden illness while I am engaged in the Event, and I agree to accept all financial responsibility for any such medical treatment and transport.

I understand that PRT staff and/or other designated PRT representatives or contractors may take photos and/or video of the Event that may include the image, likeness and/or voice recording of me participating in the Event, and I also give PRT and/or other designated PRT representatives or contractors the rights to so record and utilize the image, likeness, and/or sound of my voice as recorded by photograph, audio, or video without payment or any other consideration. I understand

that the image, likeness, and sound of my voice may be edited, copied, exhibited, published, or distributed, and I waive the right to inspect or approve the finished product wherein my image, likeness, and/or sound of my voice appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of my image, likeness, and sound of my voice as may be captured or otherwise recorded during the Event. Photographic, audio, or video recordings of me participating in the Event may be used for ANY LEGAL USE OR PURPOSE by PRT and/or other designated PRT representatives or contractor, and there is no time limit on the validity of this release nor is there any geographic limitation on where this material may be distributed.

I further understand and agree that while present on PRT property, I am required to follow any governmental/public health authority, and/or PRT orders or safety guidelines (collectively, the “Safety Requirements”) pertaining to the **Bus Rapid Transit Alignment** specifically or to PRT facilities generally that are provided to me. I understand that any such Safety Requirements deemed specifically applicable to the Event by PRT will be explained to me upon arrival at the **Bus Rapid Transit Alignment**.

In the event any clause, term or provision of this agreement shall be declared or adjudicated invalid for any reason, such declaration or adjudication shall not affect the other clauses, term, and provisions hereof, which shall remain in full force and effect, as if the clause, term, or provision so declared or adjudicated invalid were not originally a part hereof.
