



GENERAL RELEASE, ASSUMPTION OF RISK AND INDEMNITY – Cycling

I acknowledge and agree to the terms and conditions set forth in this waiver and release of liability (hereinafter referred to as the "Waiver") in consideration of being permitted to participate in the cycling activity ("Activity") organized by Friends of the Riverfront ("FOR").

Assumption of Risk: I understand and acknowledge that the Activity involves inherent risks and dangers, including but not limited to risk of injury or death, risk of damage to personal property, and risk of accidents occurring during the activity or while transporting equipment. I voluntarily choose to participate in this event despite these risks.

Release and Waiver: In consideration of being allowed to participate in the Activity, I hereby release, waive, discharge, and hold harmless FOR, its directors, officers, employees, volunteers, agents, and representatives, and any other related, sponsoring or promoting party, municipality, landowner, or their successors and assigns, as well as their officers, directors, agents and employees (collectively, "Sponsoring Parties"), of any liability or claim because of or related to my participation in, or travel to or from, the Activity from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or to any of my property, whether caused by the negligence of the Sponsoring Parties or otherwise. This release and waiver shall extend to any claims arising under Pennsylvania law.

Indemnification: I agree to indemnify and hold harmless the Sponsoring Parties against all liability, claims, demands, actions, or causes of action, including legal expenses and attorney's fees, arising out of or related to my participation in the event. This indemnification shall extend to any claims arising under Pennsylvania law.

Governing Law and Jurisdiction: This Waiver shall be governed by and construed in accordance with the laws of Pennsylvania. Any legal action arising out of or related to this Waiver shall be brought exclusively in courts located in Allegheny County, Pennsylvania.

Severability: If any provision herein is found invalid or unenforceable, the remaining provisions shall remain valid and enforceable.

Medical Care: I authorize FOR to obtain emergency medical or hospital care for me if, during my participation in the Activity, I need such care and am unable to obtain or arrange for it myself. I acknowledge my liability to pay for such care.

Photo/Video Release: I irrevocably grant and convey to FOR all right, title and interest in any and all photographic, film, video or audio recordings made by FOR during the Activity, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

I certify that I am at least 18 years old, and that by signing this Waiver, I affirm that I have carefully read and understand its contents and voluntarily agree to its terms and conditions.
